Town Park Base Plan: Jim Bolduc from Lepene Engineering & Surveying, LLC came before the Commission and explained in detail what has been done to date on the plan. Jim also presented the Commission with a Boundary Plan. Jim hopes to attend the June meeting with a finished plan. The Commission thanked Jim for the update on the project.

Winnisquam was cleaned by Thomas Arena, a Bishop Brady student. The Commission sent a thank you note to Thomas for valuing his commitment to his community.

Play Soccer: Soccer camp is reserved for Monday, July 20<sup>th</sup> to Friday, July 24<sup>th</sup>. A minimum of 20 campers will be needed to hold camp this year.

Tennis Lessons will be held at WRHS tennis court. Three different time slots will be offered on Monday evenings on June 22, 29 and July 6, 13.

Golf Lessons to be held at Den Brae Golf Course. Three sessions will be held. First Session dates are June 4, 11, 18 & 25. Second and third session dates are July 9, 16, 25 & 30.
