

# Town of Sanbornton ~ Recreation Commission~ Meeting Minutes

June 11<sup>th</sup>, 2013 ~ 7:00 p.m. ~ Town Park

**Attending:** Wood, Goodwin and Smith.

**Meeting Minutes:** From March 12<sup>th</sup>, 2013 were read. **Motion:** A motion was made by Mr. Smith and seconded by Mrs. Goodwin to accept the meeting minutes. **Vote:** Affirmative – Unanimous. Due to lack of quorum no meeting were held on April 9<sup>th</sup> or May 14<sup>th</sup>.

**Financials:** Poll Vote: I am requesting ordering 120 tons of playground wood chips from Cousineau Forest products at \$16 dollars per ton and a delivery fee of \$400.00 for a total of \$2,320.00 to come from the NLF. Confirmation of a poll Mark- Yes, Heather- Yes, Guy- Yes, Tracy – Yes and no response from Joel. Financial sheets from March – May were reviewed.

**T-Ball:** The season was scheduled to end last Saturday but due to rain, we will end the season on Thursday evening. The teams have played against other towns and have had good experiences. On Thursday, players will receive certificates and make their own sundaes.

**Summer Day Camp:** Is scheduled to open in a few weeks. Our current numbers are good and we expect more before camp starts. The following are current numbers: Week #1 (38), Week #2 (27), Week #3 (27), Week #4 (32), Week #5 (35), Week #6 (30) and Week #7 (32). New field trips are in this year's camp and camp should be a lot of fun. Discussion regarding scholarships was discussed. Lonergan will look into and get back information on how other recreation departments handle their scholarship application process.

**Playground:** Discussion on installation was reviewed. The surface area around the playground (outside of the wood chips) was also discussed. Lonergan is waiting to her from Home Depot on if they will be able to install the fence on the back side of the playground. Once the fence is installed we have offers of plants to make a nice garden.

**Tennis Lessons:** We had only two signs as of today however I believe we will have two more signing up so that the program can run.

**Beaches:** Lonergan updated that only one staff member was returning and that two new guards have been hired. Lonergan also noted that some days we would not have coverage as we needed one more guard. She will make sure the busier days are covered. Sadly due to no one applying for the Water Safety Instructor we will not offer swim lessons this summer.

**New Business:** Next month's meeting is scheduled for July 9<sup>th</sup>. **Motion:** A motion was made by Mr. Smith and seconded by Mrs. Goodwin to not hold monthly meeting in July. **Vote:** Affirmative – Unanimous.
